Confirmation Of Booking

Your booking will be confirmed once we have received a completed and signed booking form plus appropriate payment. Please note that your payment and completed booking form is acceptance of the booking conditions and is non-refundable.

Cancellation of Booking

If you wish to cancel your booking you must notify us in writing. Until written confirmation is received we will continue to hold your reservation. All written cancellations will be acknowledged and cancellations will incur the following charges:-

Socccercamp & Multi-Sports

62 days or more before booking date:	loss of deposit
62 to 14 days before booking date:	50% cancellation
14 days to booking date:	no refund

Play 'n' Stay

62 days or more before booking date:	loss of deposit
62 to 28 days before booking date:	75% cancellation
28 days to booking date:	no refund

Payment

Once you have completed and signed the booking form please forward the form by fax, email or post (address on contact page). If paying by cheque please make all cheques payable to Socccercamp International Ltd. And if paying by credit card please ensure you complete all the details. Please note that for all credit card payments there is a 3% surcharge which will be added to your total bill.

Booking Details

It is the responsibility of the parent/guardian to ensure that all the information on the booking form is completed in full and is current and upto date information. It is the responsibility of the parent/guardian to advise us of any changes.

Payment

All pre-bookings must be paid in full. Please check the due dates on your confirmation.

Administration Charges

Please note that we do reserve the right to levy an administration charge of £20.00 per change in respect of any changes or amendments.

Socccercamp Tee-shirts and Water Bottles

Each child booked in at Socccercamp/Multi-Sports will receive a tee shirt and water bottle at registration. The allowance is one set per child and if either of these items is mislaid they can be purchased from our staff at the reception desk.

Personal Property

All personal property is the responsibility of the owner. Incompatibility

Programme Changes

Visas and Passports
